Twin River and Newport Grand are slot parlors located in Lincoln and Newport, Rhode Island.

Hollywood Slots is a slot parlor located in Bangor, Maine.

It is estimated that, since 1993, Massachusetts residents have spent more than \$10 billion at Connecticut's resort casinos and Rhode Island and Maine's slot parlors, and Bay Stater spending has generated \$4 billion in tax revenues to the Connecticut, Rhode Island and Maine state treasuries.
